Notes

1. The compensation amount is calculated in accordance with the requirements of the Public Sector Compensation Disclosure Act. Compensation includes the total amount or value of all cash and non-cash salary, wages, payments, allowances, bonuses, commissions and perquisites, other than a pension as well as all overtime payments, retirement or severance payments, lump-sum payments and vacation payouts, payments made for exceptional benefits not provided to the majority of employees, and the value of the benefit derived from vehicles or allowances with respect to vehicles. Mandatory Life Insurance premiums are not included.

The Public Sector Compensation Disclosure Act requires public sector bodies to disclose the name and compensation paid to individuals who receive compensation of \$100,000 or more.
